Special Resolution of the Board of Directors

BE IT RESOLVED THAT:

- 1. The revised Bylaws of the Silver Springs Community Association dated November 4, 2020, together with any amendments, changes or modifications that are advised by legal counsel, are hereby approved, ratified and confirmed as bylaws of the Silver Springs Community Association.
- 2. Any director or officer of the Silver Springs Community Association be and is hereby authorized and directed, for and on behalf of the Silver Springs Community Association, to execute (whether under the corporate seal of the Silver Springs Community Association or otherwise) and deliver all such documents and to do all such other acts and things as such director or officer may determine to be necessary or advisable to give effect to the true intent of these resolutions.

The proposed amendment is to add the following as new Subsection 7.03(g):

(a) Meeting by Electronic Means, Telephone or Other Communication Facility.

If the Board of Directors of the Association chooses to make available a telephonic, electronic or other communication facility that permits all participants to communicate adequately with each other, a Member may participate in any meeting in which he or she is entitled to participate by electronic means, telephone or other communication facility. Participation shall be in the manner provided by the policies and procedures of the Association. A Member participating in such a meeting in such a manner shall be considered present at the meeting and at the place of the meeting. Notwithstanding any other provision of these Bylaws, any Member participating in a meeting of members pursuant to this Subsection may vote on any matter, in accordance with the policies and procedures of the Association, by means of any telephonic, electronic or other communication facility that the Association has made available for that purpose.
