President Jeff Van Wyk called the Silver Springs Community Association (SSCA) April 2018 Board of Directors meeting to order at 7:33.

1) Remarks from the Chair

5) NPC Report: Heather Mackay

The "This is my neighbourhood" Survey has been completed, but people can still send in information. Residents simply need to just need to jot down recommendations. As it stands now, most of the initiatives that were listed will be paid for and most will be completed by the end of fiscal year.

CPS will go by school and see if people are crossing properly. This will be placed on priority list and a budget attached. City of Calgary will be at our engagement night – will present there. They will bring "swag" and possibly the playground reports. Kay Thorpe who is the lead of 'this is my neighbourhood' is coming.

7) Office and Building Report

Sherry -

- The Casino money should arrive in June
- We are planning for the BBQ booking all of the sponsors and events (climbing, bike repair etc.); YMCA set up a table and had activities. Heather from the City noted that she can get volunteers including face painters and leaders.
- The Art show is this Saturday from 10-3; there is silent auctions, and great art.
- The Kids clothing sale is on April 28th.
- The Sport field strategy held a meeting March 17th. It will be implemented next spring. Increases in field costs will be starting in March, however we set prices in November. **Action:** Heather Mackay will help to support Sherry in negotiating this timeframe.

8) Financial Reports

Scott discussed the financial results which were tracking fairly well. There is less revenue from watercolour, but there are more weddings are booked then last year. There is still expected to be around \$18,000 deficit in the Preschool. The net assets funds are all in a positive position. In cash there has been a dip in unencumbered cash because we had a budget deficiency this month which we had planned for. We are going to use the \$10,000 moved last month for maintenance. The lack of pool opening is hurting the operational cash flow therefore the SSCA needs to be diligent with expenses.

A member recommended consider advertising on the inside of the skating rinks and washrooms to increase revenue.
